# 1. What is the objective of the FICCI Healthcare Excellence Awards 2022?

#### 3. Who can apply for the Awards?

Organizations that have a registered presence and operations in India can participate in the Awards by filling the application form pertaining to the relevant category.

#### 4. Can a start-up apply for the Awards?

Yes. Participating organizations must be engaged primarily in providing health care services.

# 5. Can I submit my application in any other language apart from English?

Entries must be submitted in English Language only

# 6. How do I apply?

Applications must be submitted only through the application link provided. Any entries submitted through other means will NOT be accepted.





# 7. My organisation is a nursing home, can I apply for the Awards?

Nursing homes, dispensaries, dental facilities and non-allopathic facilities cannot apply for the Awards. Participation is restricted to organizations subscribing to the allopathic system of medicine only

# 8. Can I apply in multiple categories?

Yes, you can apply in more than one category, however, you must fill a separate application form for each category.

# 9. Can I apply in the same category more than once?

Yes, you can apply in the same category more than once provided if the initiative with which you are applying is different from the one already applied

#### 10. What initiative can I apply with?

The initiative/ project should have been launched in the Indian operations of the organization in the period May 1, 2018 to April 30, 2022 with impact demonstrated and results showcased by initiative/ project in the period May 1, 2022 to June 30, 2022

# 11. How will I know that my online application has been received?

You will receive an email acknowledgement that your application has been received

# 12. Can I fill the application offline and later mail it to you?

No, the application must be completely filled and submitted online. However, we have a save as draft option that will enable to fill the application form at your pace and submit post completion

# 13. I was a winner in a previous edition for FICCI Healthcare Excellence Awards. Can I apply for the Awards?

If you're a winner in a previous edition, the winning initiative cannot be nominated again. You are free to apply for other initiatives/projects/services if they are eligible as per the definition and criteria for the category being applied for.

#### 14. Is there any application fee for the Awards?

#### **Application Fee:**

Category	Fees (Per Application) INR
Private Sector	18000/- + 18% GST
Public Sector (Govt.) / NGO / Trust / Start-Ups	9000/- + 18% GST

## 15. Can I apply if my initiative does not fit in any of the categories?

#### 16. Can I submit multiple applications in a focus area category?

Yes, you can apply with multiple entries in one focus area category if each application is for a unique and different idea/solution. In other words, only one initiative is allowed per application form in a category.

#### 17. What happens to my application after it is submitted?

Your application form will first be reviewed for completeness, eligibility, and adherence to the application guidelines, including character limit. Incomplete and ineligible applications will be declined without further review.

After a thorough review, applications that fit the FICCI Healthcare Excellence Awards criteria will be shared to an esteemed jury for evaluation
