## APPLICATION PROCESS

- The application forms are available at [www.ficcihealthawards.com](http://www.ficcihealthawards.com)
- Forms should be filled in English only
- All the fields are compulsory to be filled. Please fill (NA/na) in the fields which are not applicable. Incomplete forms or forms with incomplete sections may not be considered
- A participating organisation can send multiple entries in more than one eligible category, provided it is for a separate initiative/product/service. Each initiative/product/service would need to fill a separate online application form for each category. One form cannot be used for multiple initiative/product/service
- If multiple partners apply for the same initiative/product/service, then they should agree amongst themselves who would be the rightful owner of the initiative/product/service. The Award's management or any of its partners will not be involved in deciding the same
- A declaration is to be submitted if a third party is applying on behalf of an organization
- The Jury has the right to reclassify application forms from one category to another or reject an application form, at its discretion. This is not contestable in any manner
- It is highly recommended to provide all monetary figures in INR Crore
- Please maintain one copy of the completed form with you for your records
- Please submit up to 5 supporting documents along with the application form online. Supporting documents should be in the following formats only– pdf/jpeg. Size of each document cannot exceed 2 MB
- A declaration on company letterhead signed by an authorised signatory attesting to the authenticity of the data provided in the application for is mandatory for all entries
- Incorporation certificate is a mandatory document for all entries. In case a participant fails to submit the proof of incorporation certificate of the participating entity and start date of initiative on organization's letter head, they may be disqualified from participation
- Last date for receiving completed application forms online is 7<sup>th</sup> July 2023 till 1800 hrs

## SELECTION PROCESS

- All eligible entries will be screened by an interim Jury panel
- The Jury will have the sole right and discretion to reject entries that in their view do not meet the basic specified criteria
- Based on the evaluation framework agreed with the Jury, interim Jury will scrutinize all eligible applications received and short-list entries for online/ field visit verification
- Online verification/ Field visits to the finalists will be conducted by an independent agency nominated by FICCI to validate the authenticity of the information provided in application form/ questionnaire
- Post verification, qualified finalists will be contacted and provided with the presentation format in which they would be required to submit/present their case study
- The Award ceremony will be held in physical format at New Delhi. In case of any change in event format, the participants will be informed accordingly. The cost of travel incurred by participants, if any, would need to be borne by the participants themselves
- Award will be given only to the winners of each category during the Awards ceremony on 26<sup>th</sup> October, 2023
- There will be 1 winner in each award category, as mentioned in the category section. However, the final decision will be at the discretion of the Jury
- Jury's decision on all matters relating to these Awards would be final and binding on all participants, and non-contestable. In case the Jury does not come to a consensus on a particular category, the Jury may not award that category and proceed as it otherwise deems suitable



## ELIGIBILITY CRITERIA

- 1** Organizations that have a registered presence and operations in India can apply and participate in the Awards by filling the online application form pertaining to the relevant category
- 2** There are no minimum years of operations applicable for organizations participating, however the Certificate of Incorporation is a mandatory document to be submitted
- 3** The initiative/ project should have been launched in the period April 01, 2021 to March 31, 2023 with impact demonstrated and results showcased by initiative/ project in the period April 01, 2022 to March 31, 2023

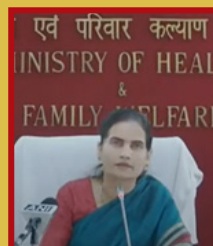
